1. Definitions:

- a. **Appliance** means the Endace-manufactured network appliances (including but not limited to physical and virtual versions of EndaceProbe);
- b. **Application** means Endace proprietary software application (including but not limited to EndaceVision, Endace vProbe, EndaceCMS, Investigation-Manager, EndaceFlow, OSm, MGD, EndaceProbeCloud, and EndaceConsole) intended to execute on an Appliance, as a virtual machine, or in a public or private cloud environment;
- c. **DAG** means the Endace-manufactured network cards and associated software including Virtual DAG (vDAG) interfaces;
- d. **DockOS** means the package of Linux along with various open source applications (SNORT, Suricata, Wireshark, etc), bundled with Endace code (DAG, and other libraries);
- e. **Intellectual Property** means copyright, patents, designs, trademarks, trade names, goodwill rights, trade secrets, confidential information, know-how and any other intellectual proprietary right or form of intellectual property;
- f. **Owners** means the author of the respective intellectual property: Endace or it’s suppliers with respect to the Software or Product;
- g. **Product** means either an Appliance, Application, Software, or combination thereof; and
- h. **Software** means any firmware, BIOS, source code, compiled code, API, or scripts (including Applications) contained within a Product, or within an electronic install package supplied in connection with a Product or supplied on its own (as applicable), including without limitation all associated media,

printed materials and online or electronic documentation, but excluding “open source” software.

2. License:

Endace and/or the Owners are the owners of the copyright and other intellectual property rights in the Software and Product. On your acceptance of this License and payment of the applicable license fees (if any), Endace grants to you a non-exclusive, non-transferable license under its copyright rights in the Software and Product and the patents to use the Software and Product upon the terms and conditions contained in this License and in accordance with its documentation.

You do not receive title to the Software or Product or any intellectual property or proprietary rights whatsoever.

Access to the Software and Product may be controlled by a License key which shall enable Endace to activate or disable the Software or Product in accordance with the terms contained herein.

3. Permitted Uses (Appliances and Applications):

In relation to the Software contained within an Appliance:

- a. the Software is licensed with the Appliance as a single integrated product and may only be used with the Appliance. If the Software is not accompanied by the Appliance, you may not use the Software; and
- b. unless otherwise expressly provided, you may use the Software solely as embedded in and for execution on the Appliance for internal business purposes.

In relation to the Software supplied for use on non-Endace supplied hardware, for use as a virtual machine, or for use in a public or private cloud environment:

- c. the Software is licensed for use in a specific target environment (ie specific hardware, hypervisor or cloud provider) and may only be used in that environment; and
- d. you may operate only up to a specified number of instances of the Software, for a set period of time, and within the usage restrictions that the license allows; and

- a. you may use and modify the source code provided for use in your product; and
- b. you may re-distribute binary versions of the code, either in its original, or in a modified form.

5. Restrictions (Appliances and Applications):

This clause 5 applies to Appliances and Applications.

- a. You must not use the Software or Product or make copies of it except as permitted in this License.

- b. You must not remove, obliterate, change or supersede from the Software or Product Endace's copyright notice.
- c. Except as expressly set out in clause 4 (as applicable), you must not sell, assign, lease, rent, loan or sub-license your rights under this License, or provide the Software or Product or otherwise make it available in whole or in part in any form to any person, without prior written consent from Endace.
- d. You must not use the Software or Product for immoral, illegal or for any other purpose which may be determined threatening, abusive or harmful including but not limited to the creation or transmission of any virus, worms, Trojan horse or any other destructive or contaminating program or the illegal interception of communications.

14. Benefit of License:

This License is for the benefit of and is enforceable by Endace and/or the Owners.

15. Export:

You must adhere to any applicable export control laws and regulations and shall not export or re-export any Product or technical data received or the direct product of such technical data except in compliance with the applicable export control laws and regulations.

16. Governing Law and Jurisdiction:

Unless otherwise agreed in writing the Licensor is as follows:

- if you are domiciled in New Zealand, Endace Measurement Systems Limited (New Zealand company 1202098) (EMS). The License will be governed by the laws of New Zealand, and the parties submit to the non-exclusive jurisdiction of the courts of New Zealand.
- if you are domiciled in Asia or Oceania, excluding New Zealand, Endace Australia Pty Limited (ACN 135 892 358) (Endace Australia). The License will be governed by the laws of New South Wales, Australia, and the parties submit to the non-exclusive jurisdiction of the courts of New South Wales, Australia.
- if you are domiciled in Europe, Africa or the Middle East, Endace Europe Limited (UK company 04834114, registered office Squires House, 205a High Street, West Wickham, Kent, United Kingdom, BR4 0PH) (Endace Europe). The License will be governed by the laws of England, and the parties submit to the non-exclusive jurisdiction of the courts of England; and
- if you are domiciled in Latin America or North America, Endace USA Limited, a Delaware company (Endace USA). The License will be governed by the laws of the State of Delaware and the parties submit to the non-exclusive jurisdiction of the federal and State courts located in the State of Delaware.
